Lowe Ranch Negotiations

The WBMD was notified in the fall of 2024 of Town of Silverthorne's intent to purchase the Lowe Ranch bordering Ruby Ranch to the north. There were immediate concerns for Ruby Ranch property rights and status of an access easement over the 1911 "Wagon Track" that would be potentially used as trail access from Smith Ranch to the Willow Brook trailhead. Members of the WBMD and HOA engaged frequently with Silverthorne and Summit County officials to negotiate the Lowe Ranch being used as open space to protect the remaining elk herd that access water along this route. Concerns for the Elk as well as potential future development required engaging a specialized law firm and public relations team as well as wildlife experts. The WBMD submitted an alternative plan to the town and county for an improved trail connecting the new 4th st crossing development to the Eagles Nest. Town of Silverthorne and Summit County intend to build a trail from smith ranch along our property to the Lowe property and beyond to the Eagles nest remains a concern. The WBMD approved and built new fencing and gate to assert our property rights at this boundary. The WBMD and HOA are actively engaged in continued efforts to protect the Elk.
